ORDER:

Under Article VII of the Memorandum of Association of the Tamilnadu Textbook Society, the Government of Tamilnadu hereby direct that the above society shall make the following amendments to its Memorandum of Association and Rules.

AMENDMENT.

In the said Memorandum of Association:-

In Sl.No.1. under Article IV for the words

"1. Education Minister.
Government of Tamilnadu - Chairman."

the words

"Secretary to Government,
Education Department - Chairman."

shall be substituted.

In Sl.No.2.

"Secretary to Government incharge
of Education - Vice Chairman.

shall be deleted and the Sl.No.3,4,5,6,7 and 8 shall
be renumbered as 2,3,4,5,6 and 7 respectively.

In Rule 15, the words
"the Vice-Chairman and in his absence"
shall be deleted.

Rule No.22. shall be deleted.

In Rule 25(a)(1)(i) the words

"Minister incharge of Education."

shall be deleted and Sl.No.(ii)(iii)(iv)(v)
(vi)(vii) and (viii) shall be renumbered as
Sl.Nos.(i) (ii) (iii) (iv) (v) (vi) (vii) respectively.

For the existing words in Rule 25(b) the following words
shall be substituted:

"The Secretary to Government, Education Department
shall be the Chairman of the Board."

In Rule 32 the words occurring in second and third sentence
and in his absence by the Vice Chairman' 'both' and Vice Chairman'
and the words occurring in sixth and seventh sentence' and the
Vice Chairman' shall be deleted.
