ORDER:

Under Article VII of the Memorandum of Assn
Tamilnadu Textbook Society, the Government of Tamilnad
that the above Society shall make the following amend
memorandum of Association and the Rules.

AMENDMENTS

I in the said Memorandum of Association, for Article. IV,
article shall be substituted, namely:-

"IV. The members of the Society to whom the management of
the Society is entrusted, are as follows:-

- (1) Education Minister, Government of Tamilnadu. ..
- (2) Secretary to Government incharge of Education ..
- (3) Secretary to Government incharge of Finance. ..
- (4) Managing Director, Tamilnadu Textbook Society..
- (5) Director of Stationery and Printing, Madras. ..
- (6) Director of School Education, Madras. ..
- (7) Director of Collegiate Education, Madras. ..
- (8) Director of Technical Education, Madras. ..

II. In the said Ruler (1) in Rule 236(a) :-
the following

- (i) Minister incharge of Education.
- (ii) Secretary to Government, incharge of Education.
- (iii) Secretary to Government, incharge of Finance.
- (iv) Director of Collegiate Education.
- (v) Director of School Education.
- (vi) Director of Stationery and Education.
- (vii) Managing Director.

(ii) In clause (b) for the words, "The Chief Minister shall be the Chairman of the Board, and the Minister for Education shall be the Vice-Chairman of the Board" the words "The Minister incharge of Education shall be the Chairman of the Board" shall be substituted.

(2) In rule 40, (i). for the entries (a) to (d) the following entries shall be substituted, namely:-

(ii) for the words "the minister incharge of Education shall be chairman of the committee", the words "the Secretary to Government incharge of Education shall be chairman of the committee" shall be substituted.

(3) The above amendments shall be given effect to after passing a Special Resolution of the Society and the amendments should be forwarded to the Registrar of Societies for registration.

(4) The question whether, an additional member need be nominated to the Board of Governors and the Executive committee will be considered separately in consultation with the Managing Director, Tamilnadu Textbook Society,
